**The purposes of the processing for which the personal data are intended:**

Joint processing of personal data of individuals to be cared for by the Federal Office of Immigration and Asylum, provincial offices appointed with the care of aliens pursuant to article 2, paragraph 1 of the Basic Care & Services Agreement, and the Federal Minister of the Interior

**Legal basis for the processing:**

Article 8 of the Federal Act on Providing Basic Care & Services to Asylum Seekers and other Eligible Aliens 2005 (GVG-B 2005) in conjunction with the Basic Care & Services Agreement pursuant to article 15a of the Federal Constitution Act (B-VG)

**The period for which the personal data will be stored:**

Data are to be deleted two years after expiry of the provision of basic care and services, provided that such is not required at this point for any pending proceedings or for the purpose of settlement pursuant to article 11 of the Basic Care & Services Agreement.

**Categories of recipients of personal data:**

Humanitarian, ecclesiastic or private institutions as appointed legal entities of the Federation or the Federal Provinces; institutions responsible for provision of means-tested minimum benefits; Public Employment Service Austria (AMS); social security institutions; fiscal authorities; administrative district authorities as health authorities; security authorities; youth welfare authorities; Austrian Integration Fund; Office of the UN High Commissioner for Refugees in Austria; foreign immigration and asylum authorities; providers of accommodation who will act for the organisations (appointed with providing basic care and services); appointed transport companies transporting aliens requiring support and protection who are eligible for support (asylum seekers, persons eligible for asylum, displaced persons and other individuals who cannot be deported due to legal or de facto reasons); the SourcePIN Register Authority within the competences set forth in the E-Government Act; Statistics Austria
